ENTRY INFORMATION

ENTRIES are limited to 15 handler/dogs (or teams). This test will not accept post entry of teams. Priority will be given to entries that have not earned titles in the division entered. Entries from within the United States will be accepted by U.S.P.S. Mail **ONLY**. Foreign entries must show a verifiable mailing date. To ensure that your entry has a legible postmark date, it is suggested that you request your entry to be hand-stamped at the post office (you may be charged an additional fee). If you use Express Mail, you **MUST** waive the signature.

No entries will be accepted with a postmark prior to February 27, 2012. All entries must be submitted on an NCA entry form, and include a copy of the dog's current AKC, CKC, ILP or foreign registration certificate. A separate entry for Saturday and Sunday is required if you wish to enter both days. Entries will be confirmed by email or you may enclose a stamped, self addressed postcard.

To accommodate all entrants in at least one of the tests, priority will be given for the Tuesday test to those NOT entered on Monday.

Entry slots will be filled according to postmark date. In the event that the number of entries received with the same postmark date exceeds the limit, vacancies will be filled and alternates will be determined by a random drawing for each day. Entries received after the entry limit has been reached will be placed on an alternate list in order of postmark and a lottery will be used for postmarks that are the same date.. Alternates will be notified immediately should an opening occur.

ENTRIES CLOSE at 5:00 P.M. on Wednesday, April 3, 2012 at the test secretary's home after which time entries cannot be accepted, altered or substituted. Entry fees for entries cancelled after the close of entries will not be refunded.

SITE DESCRIPTION

The test site will be on the grounds of the Hotel Carlisle. The basic control ring will be on a tennis court, or if unavailable, a flat grassy area. The maneuvering course will be on a grassy area and utilize man-made and natural obstacles. The freight haul will pass through the hotel grounds over grass, gravel and paved surfaces. There may be curbs that will require the assistance of the handler to cross. There will be other dog events in progress on both days near the draft test site, and lots of people with or without dogs in the vicinity.

DIRECTIONS TO THE SITE

The Hotel Carlisle, 1700 Harrisburg Pike, Carlisle, PA 17015, is located on US Route 11, two and a half miles north of exit 226 off the Pennsylvania Turnpike (Interstate 76) or at exit 52 off Interstate 81 to US 11 North / Harrisburg Pike.

DOGS ELIGIBLE TO COMPETE

The NCA Draft Tests will be open to purebred Newfoundland dogs at least 18 months of age. The word "dog" in the NCA Draft Regulations refers to either sex. All entered dogs must have an AKC, ILP or foreign registration number.

AWARDS and TROPHIES

Each entrant will receive an exceptional hospitality gift which the Draft Test committee believes will be "...*better than all the rest!*" Each qualifier will receive a unique trophy selected by the Draft Test committee.

The Penn-Ohio Newfoundland Club will be offering some awards that will acknowledge a "*better than all the rest*" performance in specific exercises during the test, such as "Best 90 degree turn, Best Backing in the Maneuvering course, etc. The performance exercises will be chosen randomly and will vary from day to day. No notice will be given to exhibitors as to which "Best" awards will be presented. You will not have to pass the draft test to be considered for a "Best" award. You need only be the "Best" in an exercise as deemed by our judges at the close of the test.

JUNIORS

To encourage participation in Working Dog events, Rhoda and David Hartmann will give a \$25 gift card to Barnes & Noble to anyone under 20 years old who completes the test as a handler or works for the test as a steward or other volunteer.

SPECTATORS AND UNENTERED DOGS

Spectators, as well as unentered dogs (except bitches in season), are welcome at the PONC Draft Test. Unentered dogs will not be permitted in the test site area. As a courtesy to our exhibitors, we ask that all dogs be kept quiet and leashed or crated.

EXHIBITORS PLEASE BE AWARE.....

Each exhibitor is responsible for knowledge of the official NCA Regulations governing a draft test and the applicable standards of performance. Each exhibitor is responsible for providing his/her own draft test equipment including loads for the freight haul.

NCA POLICY ON DOG AGGRESSION

Please police dogs carefully

“Any dog, that in the opinion of the Event Committee, attacks a person or a dog at an NCA working event, resulting in an injury, and is believed by that Event Committee to present a hazard to persons or other dogs, shall be disqualified. When the Event Committee pursuant to this section disqualifies the dog, a report shall be filed with The NCA Board. The disqualified dog may not again compete at any NCA working event, nor be on the grounds of an NCA working event unless and until, following application for reinstatement by the owner to the NCA Board, the owner receives official notification in writing from the NCA Board that the dog’s eligibility has been reinstated.”

Safety rules

1. Dogs must be crated or on leash at all times.
2. When on leash, the length of the leash must not exceed SIX feet and may NOT be a retractable leash.
3. When on leash, dogs must be under control at all times.
4. Dogs showing uncontrolled or aggressive behavior will be asked by the event chair, a board member, safety officer or other official to leave the site promptly or be crated for the duration of the event.

DOGS NOT BEING TESTED AT THE TIME are not permitted in the official Draft Test Areas. As specified in the Draft Test Regulations, 90 minutes before the start of judging, handlers and dogs (except bitches in season) are allowed a 30-minute period to familiarize themselves with the test area. Handlers may walk with their dogs on lead but not hitched to an apparatus. Handlers will not be permitted to walk the Maneuvering or Distance Freight Haul courses after this time period.

BITCHES IN SEASON may participate in NCA Draft Tests. Bitches in season will be tested at the end of the competition after all male dogs are judged. When not being tested, bitches in season must be contained in a designated area well away from male dogs and the official test areas.
